Approval of Minutes

Chair Britton Banowsky called the meeting to order at 9:02 a.m. with a welcome and an introduction of all attending.

A motion to approve the minutes from the MDHA Board of Directors meeting Friday, January 29, 2016 was made by Mike Peterson and second by Edd Eason. Motion passed.

Amendments to the MDHA/Continuum of Care Bylaws

The Bylaws have been reviewed and updated.

Board member terms will be set at three years, instead of two.

A motion was made by Connie Wilson to accept the revised Bylaws and second by Stacy Brown. Motion passed.

Nominating and Governance Committee

Molly Can Ort is currently serving as the Nominating Committee. Other Nominating Committee Members include Edd Eason, Connie Wilson, Paige Flink, and John Castaneda. Board terms are from January 1st through December 31st.

A motion to reappoint the 2015 Board Members for the 2016 year was made by Britton Banowsky with the addition of George Ellis who will serve one year. His term will expire at the end of 2016. A second was not needed since this was a nomination from Committee. Motion passed.

Edd Eason and Dustin Perkins serve on the Board as elected officers of the Continuum of Care General Assembly per bylaws and will roll off at the end of 2016, but will be replaced by new CoC elected chairs.

I45 Tent Encampment

MDHA is working directly with clients under I45 while the City is working to create a plan.

Currently, there is list of 167 people living in the tent city encampment located under I45. 60 of the clients are receiving direct case manager by 4.5 full time staff from partnering agencies.

There is a team of volunteers and staff assisting with the purchase of critical documents on Thursdays through the end of the process.

Monday at 1:00, there will be a town-hall meeting to discuss services, shelters, other camps, and the concerns of the surrounding neighborhoods. During the town-hall, a count will be to see if the number has changed.

A partnership has also been formed between domestic violence and trafficking agencies to assist with the removal of abused women. So far, three women have been removed and taken to safety.

There will be a sweep to empty the encampment. Eviction Notices will be distributed next week by Crisis Intervention and the I45 case managers and will be issued every two weeks until May 4th. The notices will include the case managers' contact information.

The City of Dallas assisted with identifying additional space at the Bridge which will accommodate fifty beds. The Bridge is working with Dallas Life to develop a plan which will allow for an increase in beds at Dallas Life. The clients will receive case management from the Bridge. to house at night and allow them to come to the Bridge for day resources

Banowsky discussed the Mayor's meeting with Board Chairs to assist with the removal of tent city residents.

The group is focusing on three key points:

- Crisis Response System Alignment-Commit to alignment of emergency shelter, street outreach, and day shelter services so that they serve as the process by which people get housed again, quickly, measuring success by reducing the length of stay in homelessness and the return to homelessness.
- 2. One Data System-Commit to a single Homeless Management Information System (HMIS) to record and store client-level information on the characteristics and service needs of homeless persons served by all homeless service providers in order to coordinate care, manage operation, provide accountable performance and significantly improve client access to housing.
- 3. Create Opportunities for Housing-Commit to a homeless response system that is built on a philosophy of rapidly returning persons into housing and supported by housing inventories, resources, placement specialists, navigators, coordinated assessment and a community dedicated to increase the supply of second chance and affordable housing for extremely low income households.

The next meeting will be held Friday, April 1, 2016 at 2:00 p.m.

MDHA President's Report

The State of the Homeless Address will be held Tuesday, March 22, 2016 at 9:00 a.m. at Goodwill Industries located at 3020 N. Westmoreland, Dallas, TX 75212.

MDHA is currently receiving comments for the 2016-2017 planning year which will be July 1, 2016 through June 30, 2016.

TIER 1 of the 2015 NOFA funding has been released but the operational guidelines have not been issued, therefore no one can go into contract signing. New grants are not allowed to draw down on HMIS dollars until contracts have been signed. Therefore, we are making payment arrangements with Caseworthy to pay for their services.

The CoC is requesting a plan for the upcoming NOFA process. Each agency would like a debriefing on how they were scored.

All other agenda items were postponed until next meeting. Meeting adjourned at 11:30 a.m.
